## BIOGRAPHY

Mirjana (Ivan) Stevanović was born on May 9th, 1970 in Smederevska Palanka. She finished Primary school in Glibovac, and the secondary school at the Educational Centre "Žikica Damnjanović" as the student of the generation. She was awarded "Vuk Karadžić" diploma. Also, during her primary and secondary education she received a number of diplomas, accolades (diplomas "Branko Radičević", "Janko Veselinović", "Jovan Jovanović Zmaj", "Tito, revolution and peace", the Certificate for the completed Youth Political School, as well as the Pioneer School for Self-governors). She acquired her higher education in 1995 on the Law Faculty in Kragujevac. She graduated from The Faculty of Management in Zaječar, the Megatrend University in 2001, and earned a degree in Economics. She passed the professional exam at the Ministry of State Education and Local Self-Government on February 24th 2005 in Belgrade, according to the programme – Rulebook on the Programme of Material of the general part of the professional exam for employees with high and higher education employed in state administration bodies-Official Gazette no. 42/93. She enrolled in Master Studies in 2005 at the same faculty, and acquired the title of Master of Economic Sciences on January 31<sup>st</sup> 2009 – on the following topic "Research of Influential Parameters on the Effectiveness of the Business Plan". She submitted her doctoral dissertation on March 16<sup>th</sup>, 2009 at the Faculty of Management in Zaječar, where she received her PhD on the topic "The Tax System of Serbia and Its Application in Practice" on December 12<sup>th</sup> 2011 and acquired the title of Doctor of Economics.

She began her working life and worked in the state administration for seventeen years, where she gained huge experience, especially in the field of tax system and tax policy. In the period from 2003 to 2011 she worked in the Ministry of Finance of Belgrade Tax Administration, the Branch office of Smederevska Palanka, in position of office control inspector. In 2012 she started working at the Business School of Vocational Studies in Čačak, as a substitute professor, where she was elected professor of vocational studies. In the school year 2013/14 she was engaged 90% of working time at the Business School of Vocational Studies "Prof.dr Radomir Bojković" Kruševac, and she was engaged with 10% in 2013 at the Faculty of Business Economics and Entrepreneurship in Belgrade, where she was elected assistant professor. From December 19th 2016 she worked at the College of Vocational Studies "Čačak" in Belgrade. On February 14<sup>th</sup> 2017 she transferred to Faculty of Management Sremski Karlovci, University "Union-Nikola Tesla", where she was elected associate professor. From October 2018 to October 2020 she worked part-time at Alpha BK University, Faculty of Finance, Banking and Auditing, where she taught public finance. In June 2019 she was elected acting Dean of the Faculty of Finance, Banking and Auditing of the Alpha BK University until January 2020. From March to October she taught at the Slobomir P University Bijeljina, Tax Academy – subject of public finance and tax and custom systems. Since June 2<sup>nd</sup> she was the in the position of the acting Director of the Business School of Vocational Studies "Prof.dr Radomir Bojković" Kruševac. On November 18th 2021 she transferred to the Faculty of Business Economics and Entrepreneurship in Belgrade, where she was elected full professor.
